Budget :

A large tree fell onto John Willwrath's home during the wind storm. The tree has been cleaned up, he is asking that the next time the Village does a tree service in town that the stump be removed from his yard. Council will take care of this as this was a town tree. There were several volunteers from Council to look at and possibly remove the trees at the cemetery that are dead. Council would like to appropriate tree service into next year's budget.
