# Zoning:

Janice had two complaints about properties with junk piling up on Main Street. A friendly letter will be sent before further action will be taken.

## New Business:

The Park name was discussed. Council would like the Park Committee to ask for resident input on the name of the park. This could be done at the Tree Festival or the Fire Cracker Festival. The issue will be tabled for now.

A letter will be sent to the property on North Wayne concerning junk and vehicle violations.

Flushing of the fire hydrants was discussed. When the hydrants are flushed, the Kozy Korner gets rusty water and cannot operate business normally. #### Mayor:

Kevin Nuding is interested in the vacant zoning board seat. He will be asked to attend the next council meeting.

The alley beside Mr. Nuding's property needs to be plowed in the winter since we are not closing it and it is a village alley.

The Mayor will attend a meeting to vote on a seat on the Amp Ohio Board, council was in favor of giving his vote to the Celina candidate.

Jim Godwin was present to ask about getting three phase put in at the Kozy Korner and across the street. Council was all for improving the business section of the village, but this is an issue for the Board of Public affairs. Council would like to see an estimate from Bill for putting three phase in at these locations.

The walk in cooler that was taken out of the school was discussed. It belongs to the village. Mr. Godwin would like to have it for his business. April stated the Mr. Godwin has been very generous to the town by letting us use storage units for free for the past two years. Council must establish a value on the cooler, Judy will check into the proper way to handle it. The village will never have a use for the cooler.
